As of 1 Jan 2024, the new Springly Database notes the Department of TN membership to be 2106; including 1926 Life Members and 180 Annual Members. 163 have renewed and we have 17 new members. Nationally, Tennessee ranks 17th in membership and 2nd in District III. As a department, our 17 Posts are struggling with the new Membership management system. It seems "Springly" is not fully functional and is not user friendly. Many posts have found that when the prescribed filters are used, there are inconsistencies in the results. When downloading the "current membership filter and lifetime memberships" into the Excel spreadsheets, many lifetime members have the 'date they converted' as their 'expiration date, instead of the 1/1/38 date it should be. About 10 % of the membership with 'expired dates' of 8/31/23 actually have up to date annual membership that expire 8/31/24 when a comparison data search, back to "Springly" are done. The Executive Director and 1st Vice Commander have started screening each post for accurate records.

Programs

TN participation in National Programs continue to be active.

- Americanism Contest entrants have noted the topic "Why is it important to Vote" as very fitting, with the presidential election coming up in November.
- Our TN attendee to the National Youth Conference in Valley Forge, provided a very favorable report on her experience.

This additional 1272 Veterans would bring membership up to 4358! For a secondary project, these members will be contacted to encourage re-joining the organization.
- 3. There are locations within the Department that are being evaluated and considered for new posts.

Programs

- 4. Programs for the reporting period of January 1 June 30, 2023, included 29 out of 29 posts (100%) reporting programs online in the new database. These reports included 1,096 volunteers who performed 12,658 hours (\$361,259.32) in services that covered 62,954 miles (\$26,440.68). Outgoing donations totaled \$9,523.00 and activity costs totaled \$4008.30. The overall value of reported programs is \$401,231.30.
- 5. Programs for the reporting period of July 1 December 31, 2023, included 29 out of 29 posts (100%) reporting programs online in the new database. These reports included 950 volunteers who performed 269,582 hours in services that covered 404,396 miles. The overall value of reported programs is \$8,030,767.88.

Martin Payne is also at St. Louis VA Medical Center - Jefferson Barracks (JB) on Mondays, Wednesdays, and Fridays. Carolyn Truvillion covers Tuesdays and Thursdays at JB. William Sifford works 9 a.m. - 3 p.m. at O'Fallon City Hall on Mondays and Wednesdays.

Two service officers also volunteer at H.E.R.O.E.S. Care in High Ridge, MO. Carolyn Truvillion is there on Wednesdays and William Sifford is there on Thursdays. All 4 service officers recently completed training in Springfield, MO, during the first week of October.

The Department is currently seeking a replacement for the Service Officer lost in the Kansas City area along with filling positions in Columbia, Poplar Bluff, and the Springfield area. The long-term plan is to have a Service Officer in each of the 5 VA Hospitals in Missouri and in the VA Clinics.

This act additionally allows members of the Missouri National Guard to make a one-time transfer of the educational assistance to a dependent spouse. Spouses seeking to received educational assistance shall provide a certificate of satisfactory service of the member's National Guard duties along with proof of a cumulative GPA of at least 2.5 on a 4.0 scale while attending the approved institution. First reading completed 1/11/2024. No amendments found.

25. Senate Joint Resolution (SJR) 58 – Sponsored by Tony Luetkemeyer (R – District 34).

This resolution exempts certain disabled veterans from property taxes.

This constitutional amendment, if approved by the voters, expands the current exemption from real property taxes for former prisoners of war with a total service-connected disability to all disabled veterans, as defined in the amendment.

First reading completed 1/11/2024. No amendments found.

- Provides a retail sales and use tax exemption for sales on a military reservation by a nonprofit that operates an adaptive recreational facility that serves disabled veterans and members of the armed forces. HB 1869 National guard recruitment HB: Provides a referral bonus for a National Guard member whose successful recruitment results in an enlistment contract. Provides a reenlistment bonus to a National Guard member who extends his or her service for at least two years. SHB 1905 Equal

pay/protected classes SHB: Amends the Equal Pay and Opportunities Act to prohibit an employer from discriminating in compensation and career advancement opportunities against similarly employed employees based on the employee's age, sex, marital status, sexual orientation, race, creed, color, national origin, citizenship or immigration status, honorably discharged veteran or military status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a person with a disability. HB 1917 Physician assistant compact HB: Adopting the physician assistant compact. Exempts certain information and data relating to physician assistant multistate licenses and applications from the Public Records Act. - Expands county eligibility for the WDVA's Veterans Service Officer Program, and prioritizes funding for those counties where the number of veterans receiving benefits is below the national average and for counties that do not have a veterans service officer.
- Requires the WDVA to provide reports every two years that include, by county, the number of resident veterans and the services available to veterans. SHB 1939 Social work compact SHB: Adopting the social work licensure compact. HB 1943 National guard ed. grants HB: Expands eligibility for the Washington National Guard Postsecondary Education Grant to the spouse or dependent of a Washington National Guard member.Extends eligibility for the Washington National Guard Postsecondary Education Grant from five years or 125 percent of the published length of the student's program to six years or 150 percent of the published length of the student's program. HB 2004 Military student early reg. HB: Requires institutions of higher education that provide early course registration to allow students who are eligible veterans, national guard members, active duty military members, and their spouses,

domestic partners, and dependents early course registration. SHB 2014 Definition of veteran SHB: Standardizes requirements relating to qualifying discharges for the purpose of establishing eligibility for various benefit programs for veterans.

- Provides a definition of "qualifying discharge." SHB 2203 Incarcerated veterans pilot SHB: Creates a pilot project to assist incarcerated veterans with reentry into civilian life.
- Appoints a reentry navigator to assist incarcerated veterans with a reentry plan that will address housing, employment, education, and access to services.
- Provides a housing and reentry subsidy to assist veterans during the first year of civilian life. HB 2340 Military service/DOL fees Reducing department of licensing fees for Washington residents who have served in the military. SB 5803 National guard recruitment SB: Establishes the Washington National Guard member referral incentive program, which provides a referral bonus of no more than \$500 to Washington National Guard members who make a successful referral.
- Creates the National Guard reenlistment bonus program, which provides a reenlistment bonus to eligible members who extend their term of service in the Washington National Guard. SB 5845 Military housing taxation SB: Repeals the military housing property tax and leasehold excise tax exemptions beginning in calendar year 2025. SSB 5871 Definition of veteran SSB: Expands veterans' eligibility for purposes of state benefits and services for veterans. SB 6000 Military service credit SB: Expands no-cost interruptive military service credit eligibility in the state's pension systems to members who were awarded a service medal. SB 6238 Property tax/veteran widows Updating thresholds for the property tax exemption for widows and widowers of honorably discharged veterans. SB 6280 Veteran parking privileges Providing for veteran parking privileges.

Service

As reported at last NEC, the AMVETS Department of Washington Service Department has closed

pending new hires. The previous Director and staff resigned taking on new positions. Since that time the Department has worked with the IRS to establish a new EIN number and is currently in the process of reestablishing a new contract with Washington State DVA New hires are pending. Under a new contract there will be two performance requirements that must be met, the claims approval rating "batting average" and the cost per claims. The contract arrangement will serve Veterans through increased assistance in evaluating and processing valid claims and it serves the citizens of the State through increased revenues generated when Veterans receive monetary benefits through successful claims.

Report of William (Bill) Clark, National Commander

Welcome all to the AMVETS 2024 Spring National Executive Committee meeting. Coming up on the first half of my year, it has been extremely busy, trips to Louisiana for the District III mtg, PA, NC, RI, and several local trips in MD. On the 6th of March, I am scheduled to deliver our testimony to the House and Senate committees on Veterans Affairs.

There have been two meetings, so far, for the Rolling to Remember event. It is building into being a great success for 2024! As you know, the ride will take place Memorial Day weekend with other events, i.e. blessing of the bikes at the Washington National Cathedral and the night vigil at the Vietnam Wall.

Both new computer programs, for programs and membership are up and running, usual glitches that accompany any new system are being corrected. Membership videos are now available to help Departments and Posts to navigate the new system. We are sending in "groups" of questions that are being addressed (in video) by Springly for distribution. I am asking all Posts and Departments to work together to create constructive criticism to help better the program.

The National Headquarters building has been sold to another non-profit organization that owns a building in the same complex. The contract was fully ratified on the 8th of February 2024 and OurCare Inc. will take possession of the building on 30Apr24. The headquarters relocation committee has been working toward finding a suitable location for our new headquarters, researching many regions and recently visiting two potential sites.

The Freedom Foundation has been purchased by the Union League Legacy Foundation of Philadelphia, PA. The new name will be "Founding Forward." The new concept will be civic education for both students at the high school level and teachers who can attend a summer course at Liberty Hill, a location owned by the ULLF. A strategic plan is being developed and is projected to be ready by December 2024. As of right now, it is projected to have students on site in summer/fall 2024, subject to change.

Our overseas trip is scheduled to start the week after the close of the NEC and will include Korea, Taiwan, and Hawaii.

National Commander Clark, members of the NEC,

I again thank you all for the opportunity to serve as the National 1st Vice Commander.

I really know now that the responsibilities are astronomical. When officers at this level are successful, it's because he/she has been through a lot of sleepless nights, difficult meetings, debates, and discussions.

While working with Member Support, we've had to do endure challenges all while making the system better than it was before. Back in November, the membership system seemed broken and hard to understand. We acknowledged your feedback and concerns with the new system. We continued to meet with Springly and requested more tools, more training, and more videos. Springly understood and gave Member Support the tools to give you (AMVETS) a better experience working with the new system. I know Member Support has been doing their very best to answer all your questions as they come in. We know change can be uncomfortable, but change can be good with an open mind, patience, and a little time.

For those of you who have been working in the membership system, you know there are good additions like being able to communicate with your members through the new system. You have more control when it comes to administrative tasks like profile corrections, post transfers, and authorizing our members to maintain their roster at the Post, District, and Department levels. That's a big one! We used to have to call and/or email to get Member Support to do all of those things for us. Now we can do it in real time.

I know some of you are reluctant about this new system, but we have signed the contract. We must at least try to see it through. I too was reluctant at first, but I've been talking to fellow members, getting positive feedback from them, and that even makes me hopeful.

Again, we did not switch to a new platform to make it complicated. We changed the system to make it compatible with Programs and Membership. Communication between Programs and Membership through the reporting portion makes Revalidation an easier operation because it can automatically give the newly elected Officers access to whatever office they are elected to. That

is the method to our ideology, but it takes time. We have to take steps along the way to get it right, and keep you informed at each level. So please give time, time.

The concerns of AMVETS across the country have not been unheard and the Programs department has been driving on. The new software is working and if you are having trouble making reports for yourself, your post, or your department or having trouble in accessing Airtable to see reports reach out to our office immediately.

It is VITAL that you understand there are two web based programs used in reporting. One is the reporting side ANY AMVET can access at www.amvets.org/submit-reports and the other is Airtable which only IDENTIFIED PERSONS in your department have access to for generating reports on the data that has been submitted via the reporting side. If you feel you should have access to Airtable please talk to your Department Commander and get a letter of recommendation sent to the programs department and we can get you access.

We will be having in person training on the software and programs reporting this year at Convention. We ask that you bring a laptop, preferably the one you will be using to do reporting. We will have some Chromebooks available but if possible, bring yours so we can troubleshoot any problems that may arise there.

AMVETS is doing great work with programs reporting so far this year for the period January 1, 2024 to February 11, 2024. nationally we have reported \$3,183,186.07 worth of programs. Great work so far! Amazing numbers for only having 45 days of reporting at the time I write this report.

Together we can overcome any obstacle in our path! Keep reporting everything you do in the service of veterans.

Some key dates to keep in mind:

- 1. January 1, 2024 June 30, 2024 Program Reporting Period 1
- 2. July 1, 2024 December 31, 2024 Program Reporting Period 2
- 3. August 7-11, 2024 National Convention

You have a one week grace period after the close of the reporting period to get in your data. If you don't get it in

by then please contact our office to make sure it can be added to the report. Please report your programs as you complete them and do not miss the reporting period.

Do your part to show the great things we do!

If you didn't see the January Newsletter here is some info, I would like to share with you all:

What is an AMVETS Program?

Simply, it is the way that we provide service to veterans and our communities. When your post raises funds to help a homeless veteran get a sleeping bag and a tent that is a program. Report of Sandy Vorhies, National Third Vice Commander

Our legislative team in Washington, DC has been driving our efforts harder than ever as the end of this Congress is on the horizon. There is no shortage of turmoil in the nation's capital, but AMVETS remains confident in our mission and hopes lawmakers will set their differences aside and pass key legislation to help our veterans.

House Speaker Mike Johnson has managed to keep ahold of the gavel so far this year. Despite some snowy weather in DC, and a right flank that seems to be growing by the second, Johnson successfully passed another continuing resolution to fund the government at current levels until the beginning of March.

Election year tensions are upon us as members try to push bills through or prevent controversial ones from moving. All 435 seats in the House are up for reelection in November, and one-third of the Senate is, as well. Several members are retiring this year, leading to more open seats that could swing the chambers either way. Depending on how the race for the White House goes, we may have a difficult 119th political landscape to contend with. We will be monitoring these developments closely.

We have exciting news to share regarding our progress in the House. In December, our top legislative priority was marked up by the House Ways and Means Committee. The VETT Act is moving along well, and staff members are optimistic about its passage out of the chamber. We eagerly encourage you all to reach out to your members of Congress and ask them to support making this bill a law. Our special thanks go out to Congressmen Brad Wenstrup and Jimmy Panetta for tirelessly advocating on our behalf and pushing this bill forward. We will miss Congressman Wenstrup when he retires after this term.

Our team in DC is also working with several members of Congress on a new mental health bill. We hope to have more information for you during Legislative Advocacy Week (LAW). More information about our March fly-in should be coming your way soon. Keep an eye on your calendar for March 6, when AMVETS

is scheduled to testify before the Senate Veterans Affairs Committee.

Looking forward to seeing you soon, and we continue wishing you well.

Eventually we will be able to put many more service officers in place to work in all 50 states and even overseas veterans.

The first investment is tough, but the overall revenue is worth the effort to support our program. Alot of credit is owed to the director and his team as they get these stores up and running. There are obstacles to overcome with city and state permits and customs. The stores are also struggling with higher utility and labor cost so price adjustments are being made to make up for it. Report of Joseph Chenelly National Executive Director

National Commander Clark, National Officers, members of the National Executive Committee, and fellow AMVETS:

Your AMVETS National Headquarters continues working tirelessly to best serve you, all our members and the entire AMVETS Family.

This second quarter of the fiscal year has been an especially busy, productive, hectic time at NHQ.

Everyone at NHQ is striving to provide top-tier service to green hats and Department leaders. I hope you will read the reports of our commander, vice commanders, and our Membership and Programs directors, to see how they continue working to improve the ways their respective departments serve you and meet their missions.

With the stroke of a virtual pen on your behalf, Commander Clark accepted a full-price offer (\$3,000,000) for the current NHQ building on February 8. Pending a couple inspections, the anticipated settlement is April 30. Our Care, Inc., a nonprofit organization, is the eager buyer.

With the sale moving much quicker than predicted, a lot of work has been done and is underway to relocate the NHQ, along with the AMVETS Ladies Auxiliary, the Sons of AMVETS, and the National Service Foundation staffs, temporarily and permanently.

The National Service Foundation is opening a building it owns in Hyattsville, Maryland, just three miles from the current HQ building, to become the AMVETS National Capital Region Office. The AMVETS family will move into that building April 15.

NSF has owned two warehouse units in Hyattsville for more than a decade. A church was renting it from NSF that entire time. In late January, NSF notified the church that the lease would not be renewed. NSF regains full control of the space, which was long ago converted into office space, on April 1.

As of the publishing deadline for this report, all staff working at the current building are preparing for the move.

The ad hoc committee appointed by Commander Clark and approved by you, the NEC, has worked nearly every day since early January. They meet formally weekly. They began by defining what a new area needs to offer. Using the criteria, coupled with comprehensive research of every state within 250 miles of Washington, D.C., they identified nine target regions.

Then they created a comprehensive list of what a new-to-us building must have along with a list of what would be nice to have. Those guidelines were then sent to commercial real estate brokers in each targeted region. The Realtors searched their areas for possible fits and provided them to the committee, which then reviewed each listing.

In early February, the committee began traveling to see properties in person that seemed on paper to match the organization's needs and wants.

Being that this report needed to be submitted for printing a month before this NEC meeting, the Relocation Committee will report its progress and any findings to the NEC in person on March 9.

The important takeaway is that the committee has shown its commitment to doing its due diligence to ensure no stone is left unturned in the quest to find the best possible building in the best possible location that can be a great home to our national headquarters for generations to come.

We at National Headquarters remain grateful for your guidance and leadership. Thank you!

AMVETS LEGISLATIVE PRIORITIES FOR THE 118TH CONGRESS

Mental Health and Suicide Prevention in the VA and Armed Forces

Since 2019, AMVETS has led the way in highlighting that mental health, more than any other issue, results in the unnecessary loss of lives for the veteran and military community. As a result of AMVETS legislative efforts insisting that the VA try new and innovative approaches to address the issue, Congress passed the Commander John Scott Hannon Veterans Mental Health Care Improvement Act. The law requires the VA to provide significant grants to community and non-profit organizations as well as requiring the VA to carry out innovative pilot programs to execute novel approaches to tackle the avoidable outcome of death by suicide.

Within this law, the Staff Sergeant Parker Gordon Fox Suicide Prevention Grant Program (SSG Fox SPGP) was established. AMVETS has been closely monitoring this effort to ensure the program is successful in treating veterans in crisis who search for alternatives to VA mental health care. In December of 2023, the House Veterans Affairs Committee held a hearing on the success of the program, highlighting organizations like the Boulder Crest Foundation and their partnerships with the VA. These organizations are proving that alternative approaches to mental health care, post-traumatic growth, and improving veterans' overall quality of life are efforts deserving of increased funding and attention.

In November of 2023, the VA released its National Veteran Suicide Prevention Annual Report. It showed overarching trends in veteran suicide, once again displaying an increase in veteran suicide since 2021. The lives of our service members and veterans continue to be our number one priority. AMVETS constantly explores legislative opportunities to address this problem, seek innovative solutions for bringing these numbers down, and do everything we can to keep them down.

Ideal legislative outcomes:

• Congressional leadership will establish a

- Select Committee on Suicide for Veterans and Servicemembers
- Introduce and support legislation that requires the DoD to establish a proactive footprint to help train servicemembers on what is necessary to live lives worth living and the components that create positive outcomes in our lives.
- Support increased Congressional oversight at the VA to understand the proportion of veterans who previously utilized VA services at any juncture and ultimately died by suicide and ensure the massive VA budget is being used in the best manner to seek alternative solutions for veteran suicide.

Create Equitable Non-Profit Policies for Veteran Non-Profits

AMVETS is committed to the passage of a bill that will allow 501c19 congressionally chartered nonprofits to receive tax-deductible donations.

For numerous Congresses, AMVETS has led the charge on legislation that will allow a tax deduction for charitable contributions to specific federally chartered organizations of past or present Armed Forces members. (Under current law, donations to such an organization are only deductible if at least 90% of the organization's membership consists of war veterans. The bill expands the deduction to include organizations that do not meet the wartime service requirement and are federally chartered.)

The non-profit designation for veterans' organizations is 501(c)(19), and this status includes tax exemption and the ability to accept tax-deductible donations. However, an outdated regulation requires these organizations to maintain a membership of at least 90% of wartime veterans to receive tax-deductible contributions. This regulation was likely created in the 1970s when nearly every military veteran was a "war veteran," defined as having served during wartime.

However, there are 2.4 million veterans who do not meet this definition. These men and women are mainly those who honorably served following the end of the Vietnam War in 1975 and prior to the Persian Gulf War in 1991. These members of the Nation's first "All-Volunteer Force" served knowing full well that they may be called into war.

This antiquated regulation negatively impacts many of America's distinguished and historic veterans' non-profits which are (or are at threat of) losing their ability to receive tax-deductible charitable donations. For example, AMVETS lost its ability to receive tax-deductible donations in 2015. AMVETS is the only one of the "Big 6" Congressionally-chartered veterans service organizations open to all non-wartime veterans. About 38% of AMVETS' 250,000 members are not wartime veterans, leaving the 75-year-old organization unable to accept tax-deductible donations.

This legislation addresses this unintended consequence in the tax code by allowing any congressionally chartered 501 (c)(19) to be eligible to receive tax-deductible charitable donations.

AMVETS is proud to have attended the House Ways & Means Committee markup of the VSO Equal Tax Treatment Act in November of 2023. We now look eagerly forward to seeing this bill get passed the House and Senate this Congress.

Support Immediate Passage of the Major Richard Star Act

AMVETS fully supports the immediate passage of the Major Richard Star Act. For nearly two decades, AMVETS has supported the Bilirakis family in their efforts to end the unfair and antiquated statute preventing veterans from receiving their earned Department of Defense retirement pay and disability compensation from the VA. It is unconscionable that we are reducing retirement pay by every dollar of disability pay received for those who have given so much in defense of our Nation.

Increase Women Veterans' Voices in Policy and Government to Address Issues Disproportionately Affecting them

Addressing mental health issues specific to women is a top priority for AMVETS. In the VA's 2021 National Veteran Suicide Prevention Annual Report, the rate at which women choose to end their own lives is over 166 percent higher than members of the same gender who never served. Male veterans, meanwhile, are 43 percent more likely to commit suicide than their peers who have only known civilian life. The rate of increase in suicides by female veterans during the COVID-19 pandemic was four times higher than for male veterans, and a significant correlation was found between suicide by female veterans and their experience with military sexual trauma (MST).

AMVETS played a pivotal role in key legislation led by Senator Gillibrand and others to reduce military sexual trauma and expand health care and benefits. We will continue to champion this issue on Capitol Hill. We will also continue to engage with Congressional staff and other VSOs on women in the military, female veterans, and issues specific to those populations.

AMVETS has also noted the astonishingly low number of veterans working as policy staffers on Capitol Hill and, more specifically, the low number of women and minority veterans working in these positions. As such, we are proud to be teaming up with the HillVets Foundation to work with them to address this shortage of women and minority voices working in these positions.

Bolster Recruitment and Retention at VA

The VA has pledged to serve our veterans' health care needs, but the means to accessing this care is different for every veteran. Millions of rural and highly rural veterans face a unique combination of factors that create disparities in health care not found in urban areas. These include inadequate access to care, limited availability of skilled care providers, and additional stigma in seeking mental health care. There is also the continued challenge of the politicization of VA health care.

AMVETS realizes that the best healthcare option for veterans will first provide a strong, well-run, and fully staffed VA. As a support mechanism, AMVETS supports the VA's utilization of private care to provide ease of care to veterans, as is often the case for veterans in rural areas. This community care program has been the subject of many Congressional inquiries during this session.

AMVETS has been a long-time leader in working to ensure that our nation's veterans receive world-class

healthcare, and we will continue to support legislation that affords the best option for veterans. AMVETS will also pursue ongoing opportunities for publicprivate partnerships with the VA to guarantee access to veterans regardless of where they live.

Create a National Veterans Strategy to align care and benefits to focus on outcomes and success

AMVETS is fully aware of the challenges of reorienting a VA system that so many veterans have come to rely on. Sadly, veterans currently existing low-lows would have benefited from a more proactive approach had it existed previously. We have to start somewhere because our current policy is misaligned, provides negative incentives, and

leads to poor outcomes.

As such, we continue to recommend that Congress create a new office with significant funding; we recommend \$1 billion to be achieved by not providing the casual annual increase to the mental health budget. The office should be given the mission of creating a National Veterans' Strategy that orients the future goals and vision of a VA that

focuses on veterans maintaining their warrior wellness and providing proactive outreach, training, benefits, and services with the intent that they go on to live lives of purpose and meaning while maintaining a state of physical wellness and understanding the components of living a mentally healthy lifestyle.

POW/MIA

AMVETS is proud of former President Trump's signing of Senator Elizabeth Warren's legislation, the National POW/MIA Flag Act, into law in November 2019. This bi-partisan legislation requires the display of the POW/MIA flag outside of high-profile Federal buildings and National war memorials throughout the year. Previous law only required the POW/MIA flag to be displayed on Armed Forces Day, Memorial Day, Flag Day, Independence Day, National POW/MIA Recognition Day, and Veterans Day.

AMVETS continues to encourage members of Congress to display the flag outside their offices, as is protocol. This legislation requires the Architect of the Capitol (AOC) to display the National League of Families POW/MIA flag outside of the entrance of the office of

each Member of Congress, unless the Member directs the AOC to not display the flag. This requirement applies only to a Member's office in a House or Senate office building within the U.S. Capitol Grounds.

Support the Increase of DIC for our Survivors

For decades, survivors have been working to garner a small increase in Death and Indemnity (DIC) payments for the men and women left behind after our servicemembers die in duty to our nation. Current payments are not even at par with federal workers. We all must ensure that these men and women who paid the ultimate price with their loved ones are well taken care of. Supporting this critical change is a small way to repay that debt and highlight that our nation is grateful for their sacrifice.

The House Veterans Affairs Committee held a hearing on this issue on January 30 of this year. They discussed increasing DIC, as well as other topics relevant to surviving spouses and children. We continue to support these efforts to improve the lives of those families.

Support the Completion of a Successful and Seamless Electronic Healthcare Record

AMVETS fully supports the VA's efforts to create a seamless and effective electronic healthcare record (EHR). For decades, the VA has faced the challenge of having to deal with a broken system of transitioning veterans from DoD to the VA. Even today, millions of veterans are suffering from lost information, lost data, paper records, and more. AMVETS also is keenly aware that VISTA is no longer a tangible option, meaning something has to take place to serve our veterans and servicemembers now adequately and in the future.

AMVETS is adamantly against using this issue for political gain and will vocally and locally fight any members who imply that ending this effort is in our nation's veterans' best interests. Nothing could be further from the truth.

However, AMVETS does support a high level of oversight and holding, particularly, the VA accountable for getting their act together on this project. When the DoD had similar issues, highly competent technical leaders were assigned to lead the implementation and were given strong authority to make decisions and

make them happen. We hear numerous insinuations that this project needs to be more adequately led by VA leadership. Numerous project managers have been assigned and reassigned, and the VA at multiple levels of leadership is failing to make timely decisions which is resulting in inadequate delays.

Even so, AMVETS is still working on our veterans' moonshot to fix this long-overdue issue. The VA needs to step up to the plate because they are failing our Nation's veterans on this front. Congress must hold them accountable and possibly lead the charge on calls for resignation. However, we will not tolerate outright calls for an end to this project for short-term political gains, as this is not in the best interest of our current and future veterans and servicemembers.

AMVETS eagerly awaits outcomes from the next launch of the EHR system at the Lovell Federal Health Care Center in Chicago, IL this March.

Readiness/Recruitment for the Next Generation of Veterans

AMVETS believes that military readiness is the cornerstone of a nation's defense strategy, ensuring that armed forces are always prepared to respond to various threats. Effective recruitment is crucial in maintaining a robust and skilled military, ready to face any challenges that may arise and safeguard national security.

AMVETS has signed onto relevant letters from the Military Coalition (TMC), endorsed bills aimed at recruitment efforts, and pursued partnerships with organizations seeking to address the health and readiness of our armed forces. We believe that addressing these challenges requires targeted recruitment strategies that emphasize physical fitness and healthy lifestyles, alongside programs within the military to improve the overall health and fitness of service members.

Membership

The AMVETS Department of Wisconsin presently has 3540 members of which 2599 are Life Members, 708 are Annual with 233 at Large members. The AMVETS Department of Wisconsin currently has 8 VAVS serving our Veterans in the following locations; Iron Mountain, Chippewa Falls, Minneapolis, Madison, King, Tomah, Union Grove and Zablocki. Our locations are opening up a little at a time. Our VAVS are doing what they can for our Veterans.

Legislative

The State of Wisconsin is considering the allowance of Veterans with a 70% or greater rating to receive their rating percentage back on their property taxes. Presently only those with a 100% rating receive their property taxes back.

Other

On December 1st we had our Winter Dance and December 2nd we had our winter SEC meeting at the Ramada Hotel in Waupaca, Wisconsin. Monies were requested by the VAVS and approved at the Hospital and Service Meeting. The SEC meeting was successful in the regard that several Posts donated money to the Commander's project which is to support the Tiny Homes in Greenbay. These homes give Veterans a temporary place to live while seeking employment until they are able to obtain housing on their own.
